ACKNOWLEDGEMENT					
I, the undersigned, acknowledge that home-based businesses shall only be allowed as an accessory use to a residential use and					
must meet the following conditions:					
A. Home-based businesses shall comply with all applicable federal, state, county, and City laws, rules, and regulations, including, but not limited to, City business taxes.					
B. No more than two (2) employees or independent contractors who do not reside at the residential dwelling may work at the					
business. The business may have additional remote employees that do not work at the residential dwelling.					
C. Vehicles parked at home-based businesses must be parked in the driveway or other legal parking spaces that are not located					
within the right-of-way, on or over a sidewalk, or on or over any unimproved surfaces at the residence. All vehicles and trailers of					
any kind located at the residence must be in compliance with applicable parking regulations, including, but not limited to,					
Article 6 of this Code. The parking of any heavy equipment, such as commercial, industrial, or agricultural vehicles,					
equipment, or machinery is prohibited.					
D. As viewed from the street, the use of residential property is consistent with the uses of the residential areas that surround the					
property. External modifications made to a residential dwelling to accommodate a home-based business must conform to the					
residential character and architectural aesthetics of the neighborhood. The home-based business may not conduct retail					
transactions at a structure other than the residential dwelling; however, incidental business uses and activities may be conducted					
at the residential property.					
E. The business activities must comply with applicable City sign regulations in Article 7 of the Land Development Code.					
F. The business activities must comply with applicable local and state regulations with respect to equipment or processes that					
create noise, vibration, heat, smoke, dust, glare, fumes, or noxious odors.					
G. The business activities must comply with any relevant federal, state, county, and City regulations with respect to the use,					
storage, or disposal of any corrosive, combustible, or other hazardous or flammable materials or liquids.
