

- 3. Replace trees damaged by Hurricane Ian. Adding 30 trees.
- 4. Add shade over existing benches.
- 5. Add exercise equipment with shade.
- 6. Curb and Landscape 3 medians.
- 7. Evaluating additional trees, sod and irrigation per discussion at the Summer Retreat



Crystal Lake Park








Lake Meade Park


