About Us

The William "Bill" Austen Youth Center features a main room spanning 1,248 sq. ft., with seating for up to 96 guests (12 round tables, 8 chairs per table). Facility rental is available on Saturdays from 12pm-9pm and Sundays from 3pm-6pm. The venue is perfect for a variety of events, including Sweet 16 parties, sports banquets, baby showers, private trainings, and graduation celebrations. We also offer a selection of add-ons to make your occasion even more memorable.

All rental packages include the use of the space, tables and chairs, bathroom access, ample parking, and the option to bring your own food and décor. Additional features include music, a party assistant, and dance lighting.

Adjacent to the Youth Center is the Eagle Skate Park, a 27,000 sq. ft. course. Private skate park rentals are available on Saturdays and Sundays from 10am-12pm. Pavilion skate park rentals are available during normal skate park hours. Please note that helmets and parental/legal guardian consent are required for all participants, with helmet rentals available on-site.

Skate Park packages include space rental, pavilion tables, ample parking, music, bathroom access, and the option to bring your own food and décor.

Thank you for choosing the William "Bill" Austen Youth Center for your celebration! To help ensure your special event goes as smooth as possible, please read over the following reminders and sign below. You will be provided a copy of the contract upon signing. Furthermore, signature below indicates that the User shall be liable for, and shall indemnify, defend, and hold the City harmless from and against all claims, suits, judgments, damages, losses, and expenses including court cost, expert witnesses and professional services and attorney fees arising out of the User's errors, omissions, failure to perform, intentional tort or negligence. The user shall not be liable to, nor be required to indemnify the City for, any portions of damages arising solely out of any error, omission, or negligence of the City, its employees, agents, or representatives. I give full permission to all foregoing to use photographs, videotapes, recordings, or any other record of this event for legitimate purposes.

Party Reminders:

- A non-refundable deposit of 50% of the price is required to reserve the date and time. **Full balance must be paid (14) days** in advance of use date. Failure to pay balance due by balance due date will result in cancellation of booking.
- All party attendees must remain in the party room. Individuals under the age of 18 must be accompanied by an adult if they leave to use the vending area or playground.
- The party cleanup is expected to be completed by the end of your scheduled party time (additional time may be purchased prior to the day of the party if desired).
- All items brought into the building must be removed when the function is over. Deliveries and pickups from florists, caters, etc. must be arranged within scheduled rental times. This is a public building: any items stored are left at your own risk.
- No alcoholic beverages may be consumed on the property. Any violations will be reported to the CC Police Dept. immediately.
- No decorations may be hung on a/c units or lighting. Any decorations except tablecloths and centerpieces must be approved by the manager. Decorations hung on walls may only be hung with painter's tape.
- Parties are responsible for all damage and cleaning responsibilities. A cleaning fee of \$100 will be charged if room is left dirty.
- Music shall be kept at a reasonable volume.
