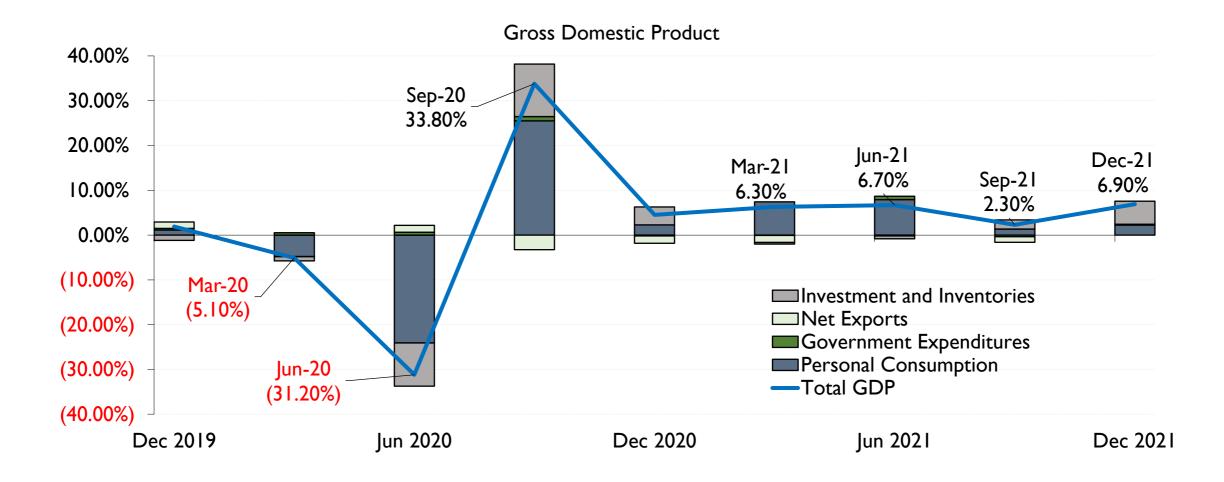

### U.S. Gross Domestic Product

➤ The U.S. economic pace of expansion expanded 6.9% during the fourth quarter of 2021, a welcomed surprise as expectations were closer to 5.5% for the period. Increases in inventories made up most of the growth at 5.15%, while consumer spending picked up from the third quarter at 2.25%. Consumer spending will need to increase in order for GDP to meet or exceed the current estimate of 3.8% for 2022.





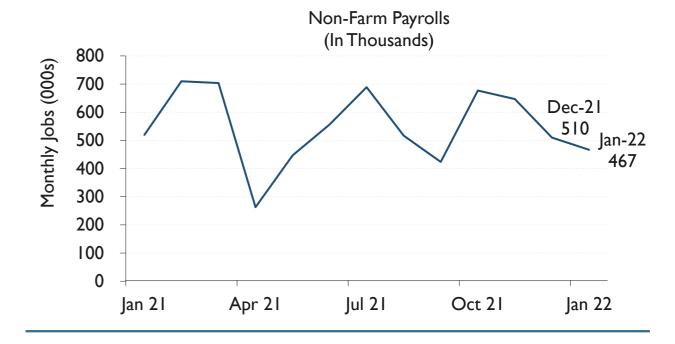
### The Labor Market

### Nonfarm Payrolls/Unemployment

- The pace of job growth finishing out 2021 was disappointing with only 199k new jobs created in December, less than half of the more than 400k expected.
- o The unemployment rate ticked up slightly higher in January to 4.0%. Another positive sign was the continued increase in the labor force participation rate to 62.2%.

### The Great Resignation

- o The Great Resignation: The record setting trend of people quitting their jobs continued during the fall, reaching a new high of 4.5 million in November and another 4.3 million in December.
- o Thirteen million people quit during the 4th quarter of 2021. Early indicators suggest the reasons are as varied as those quitting; from Gen Z to baby boomers and reasons include fatigue, lifestyle, childcare, impact of Covid-19 variants and some for better job opportunities.



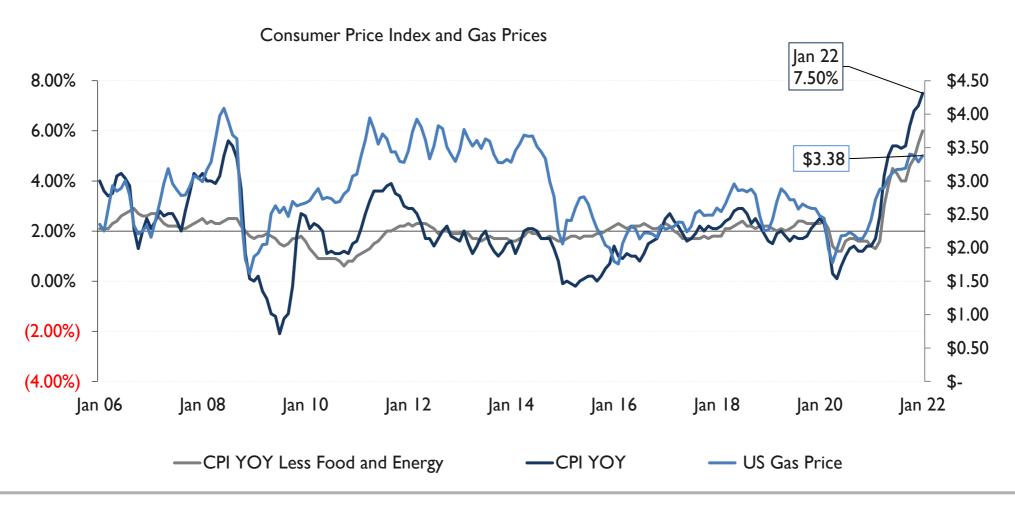

### Inflation

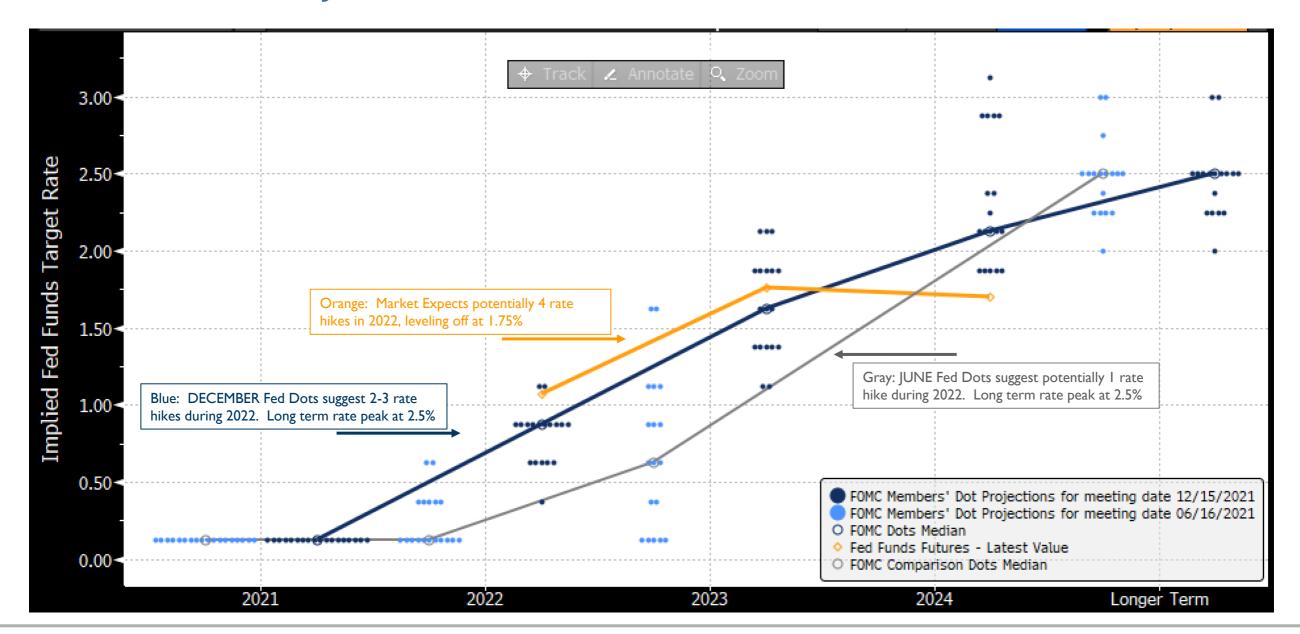
The Consumer Price Index continued its red-hot trend, posting a 7.5% (6.0% Core) year over year increase for January 2022. This was the largest year over year increase since January 1982. After months of suggesting inflation was transitory during the Spring and summer of 2021, Fed Chair Powel acquiesced in the fall of 2021 that inflation indeed is likely to be higher, and last longer than initially anticipated, a scenario many economists had predicted for months.

## FOMC Dot Plot – June 2021 vs. December 2021

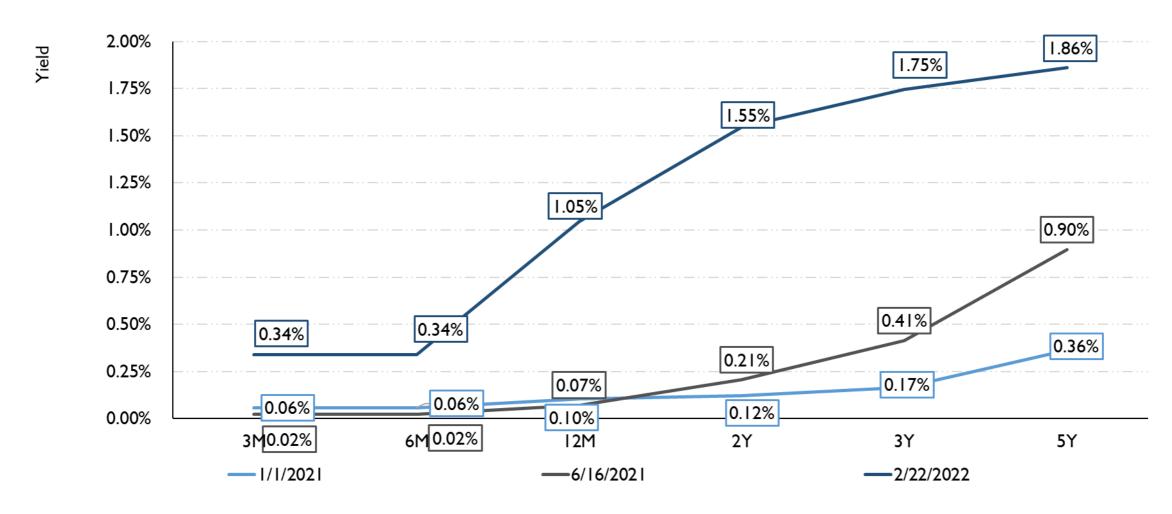




## Inflation takes hold....Slope of yield curve increases

Yields have increase 100 – 139 basis points for maturities between 2yrs and 5yrs since mid-June 2021



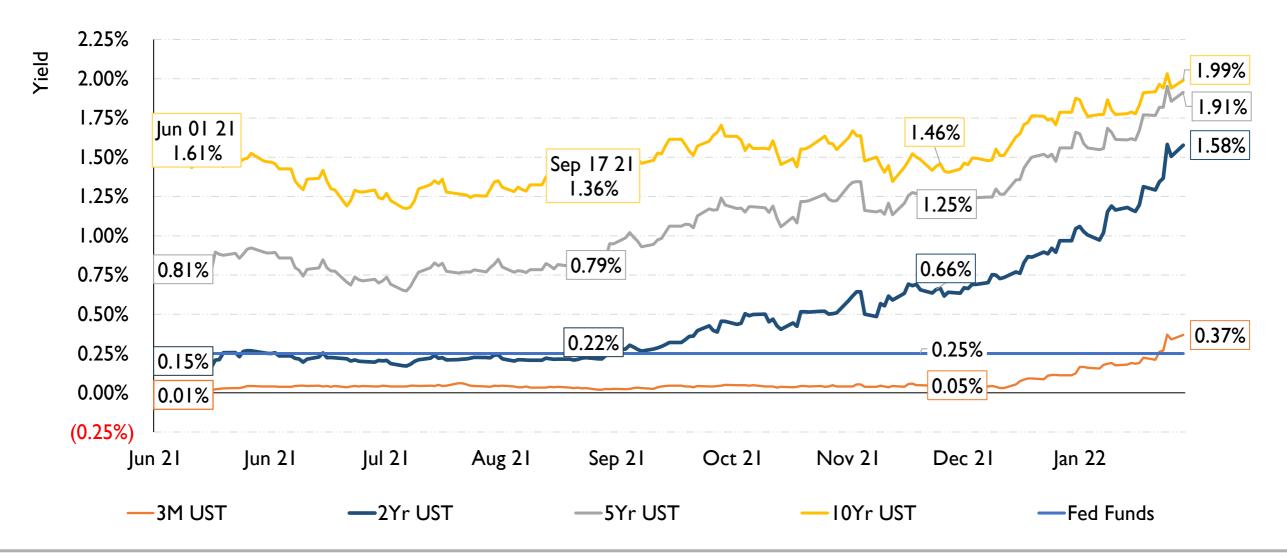

## Inflation takes hold....Slope of yield curve increases

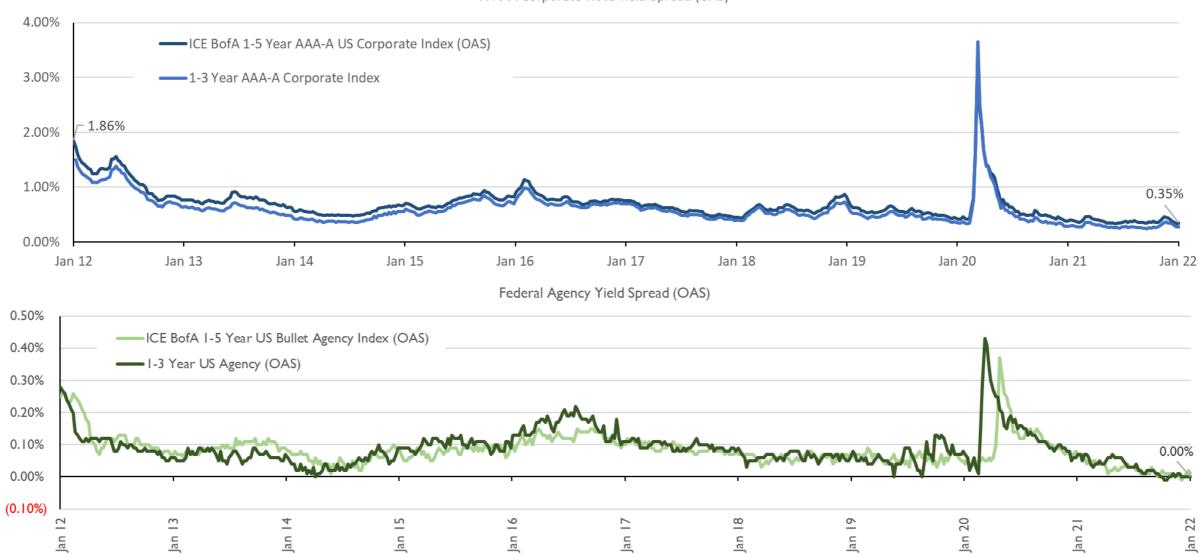






## Yield Spreads Remain Compressed

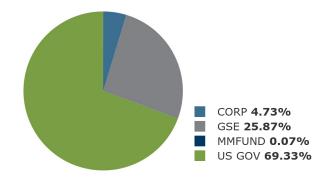

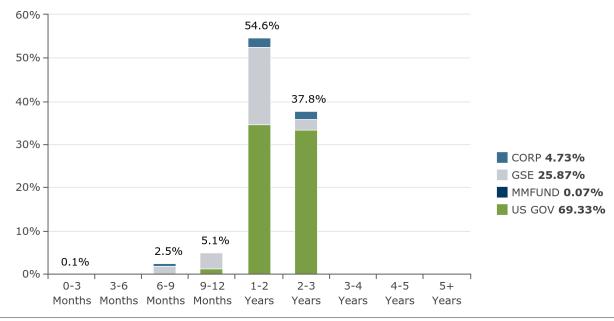

### **Maturity Distribution by Type**



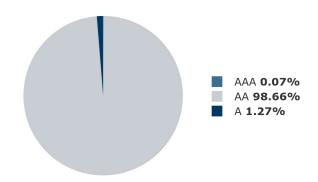

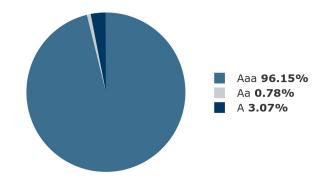

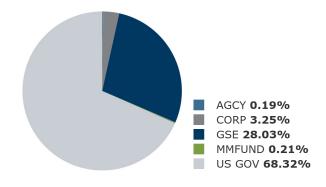

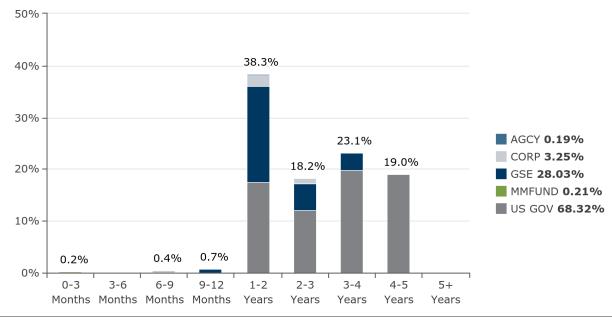

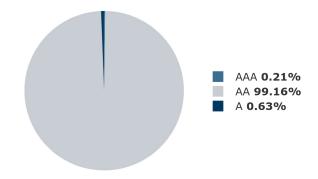

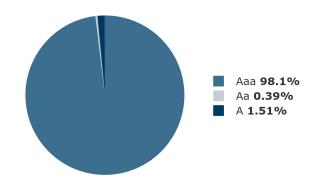

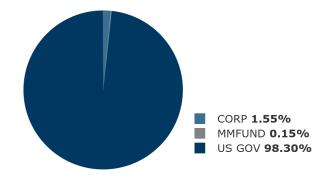

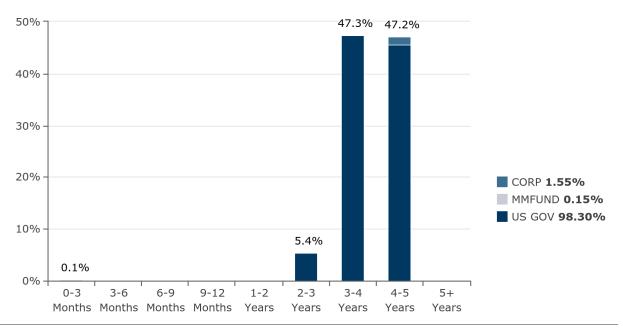

## **Maturity Distribution by Type**



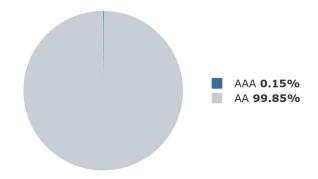

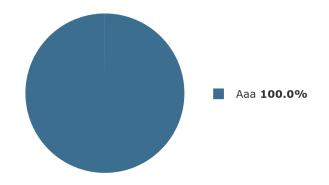

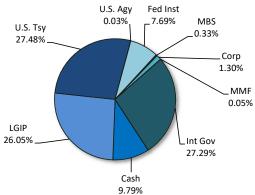
