A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, APPROVING THE FIRST AMENDMENT TO CONTRACT NO. RFQ2323KR-DD BETWEEN THE CITY OF CAPE CORAL, FLORIDA, AND Q. GRADY MINOR AND ASSOCIATES, LLC, FOR CITYWIDE PROFESSIONAL CONSULTANT CONTINUING SERVICES; APPROVING THE FIRST AMENDMENT TO CONTRACT NO. RPW2427MM BETWEEN THE CITY OF CAPE CORAL, FLORIDA AND Q. GRADY MINOR AND ASSOCIATES, LLC, FOR THE PROFESSIONAL DESIGN OF CITY SIDEWALKS; AUTHORIZING THE CITY MANAGER OR THEIR DESIGNEE TO EXECUTE THE FIRST AMENDMENT TO CONTRACT NO. RFQ2323KR-DD, THE FIRST AMENDMENT TO CONTRACT NO. RPW2427MM, PURCHASE ORDERS AND FUTURE RENEWALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor and City Council adopted Resolution 71-24 on March 20, 2024, which approved Contract No. RFQ2323KR-DD establishing a library of approved firms to provide the City with professional consultant continuing services; and

WHEREAS, the Mayor and City Council adopted Resolution 173-24 on July 24, 2024, which approved Contract No. RPW2427MM with Q. Grady Minor and Associates, LLC for the design of City sidewalks; and

WHEREAS, Q. Grady Minor and Associates, LLC consolidated its operation into Pape-Dawson Consulting Engineers, LLC on November 20, 2025, and requested that all active contracts be assigned to Pape-Dawson Consulting Engineers, LLC; and

WHEREAS, the City Manager recommends that the Mayor and City Council approve the First Amendment to Contract No. RFQ2323KR-DD to assign the contract from Q. Grady Minor and Associates, LLC to Pape-Dawson Consulting Engineers, LLC, for Citywide professional consultant continuing services, and approve the First Amendment to Contract No. RPW2427MM to assign the contract from Q. Grady and Associates, LLC to Pape-Dawson Consulting Engineers, LLC, for the design of City sidewalks, and such assignments shall be in accordance with the same terms and conditions originally set forth within the contracts.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, AS FOLLOWS:

Section 1. The Mayor and City Council hereby approve the First Amendment to Contract No. RFQ2323KR-DD to assign the contract from Q. Grady Minor and Associates, LLC to Pape-Dawson Consulting Engineers, LLC, for Citywide professional consultant continuing services, and approve the First Amendment to Contract No. RPW2427MM to assign the contract from Q. Grady and Associates, LLC to Pape-Dawson Consulting Engineers, LLC, for the design of City sidewalks, and such assignments shall be in accordance with the same terms and conditions originally set forth within the contracts. A copy of the First Amendment to Contract No. RFQ2323KR-DD is attached hereto as Exhibit 1 and a copy of the First Amendment to Contract No. RPW2427MM is attached hereto as Exhibit 2.

Section 2. The Mayor and City Council hereby authorize the City Manager or their designee to execute the First Amendment to Contract No. RFQ2323KR-DD, the First Amendment to Contract No. RPW2427MM, purchase order(s) and future renewals.

Section 3. This Resolution shall take effect immediately upon its adoption.


